Learning Resources Center

Construction on Increment One of the Learning Resources Center has begun. You have all been patiently staring at a vacant lot for quite a while and we are excited to finally be moving forward with this exciting project. Increment One involves demolition of the last remaining elements of the old LRC including retaining walls and pathways as well as grading, shoring, soil mixing and other various ground improvements. With that being said, with construction comes increased noise and activity. Noise you will expect to hear onsite include the following:

- 3. Idling trucks
- 4. Back up alerts
- 5. Generic construction noise such as power tools, hammering, etc.

Bolinas Field Station

The County of Marin has completed plan checking the drawings and approved the Building Permit earlier this month. Fundraising to raise the remainder of the project funds continues. The project will go out to bid in March and construction is scheduled to start in July 2023. There will be a ground-breaking ceremony held on July 21.

Kentfield Pool Deck

The deck of the pool at Kentfield is in the process of being repaired. Drawings are being completed and will be submitted to DSA for approval.

Indian Valley Building 21 Repurposing

The old pool at Indian Valley has been demolished and a concrete deck will be installed once weather permits. An architect has been hired for the renovation of the interior and the team

is working with the Workforce Development team on scope.

Facilities Master Plan

We want to thank all faculty, staff, students and the public that participated in the Facilities Master Plan process. We had over 50 meetings during this process. The process will be completed this February when the Board of Trustees is scheduled to approve the final Facilities Master Plan.

Other Capital Improvement Projects

Indian Valley Building 8 and 9 Improvements

The tenant improvements for Buildings 8 and 9 are well underway. Demolition of walls, replacement of HVAC units, and the updating of spaces is on schedule for completion later this spring.

Copyrights and You

We often received requests to print copyrighted material for instructors to use as class material or as part of readers and workbooks. There is a widespread perception that these types of requests fall under "fair use". However, that is not always the case and copyright laws and regulations have become increasingly strict and punishments severe for institutions or individuals in violation of these laws.

There is an increasing amount of free and less restrictive material available online. However if material has a copyright, reproducing and distributing are still quite limited and not waived just because it is permissible to download the material for personal use.

Besides the federal laws, COM has its own Administrative Policy regarding copyrights, AP 3750. It is helpful to familiarize yourself with this policy, especially if you are considering reproducing anything in question.

The "Fair Use" doctrine permits limited use of copyrighted materials, only in certain situations. There is much more involved and more details that are relevant to copyright permissions contained in AP 3750 so please familiarize yourself with it.

The COM <u>Lib Guide</u> also has some very useful and helpful information to answer your questions and assist in best practices.

How Do I Gain Permission to Use Material?

Responsibility for obtaining permission to print, duplicate or display copyrighted works rests with the individual using the copyrighted material, such as the instructor using the material for a class.

This would involve contacting the owner of the copyrighted work and obtaining written permission to use the work. Please see side bar for a list of websites which will provide additional information regarding use of copyrighted material.

Happy New Year and welcome back to the spring 2023 semester. I know all of you are busy, however I would like to request 18 minutes of your time.

As we move toward successfully completing our 2022-2025 Strategic Plan, one of our goals is obtaining 100% staff participation in watching an emergency preparedness video. This video will assist you in reacting to an emergency on our campuses. The video addresses our Emergency Guidelines Handbook, advises you of the new Emergency Provision Cabinets throughout our campuses, and trains you on how to use our new AEDs that have been installed

throughout our campuses.

This video can literally help you save a life on campus. This training qualifies for faculty flex credit.

Fiscal Services

Key Budget and Year-End Dates—2023

The following are planned year-end tasks and deadlines. A Budget Memo will be sent out in March with actual dates.

- April (2nd week): Budget Builder tool opens for updates. May (2nd week): Budget Builder tool closes.
- May (3rd week): Last day to submit purchase requisitions.
- June 15: All check requests for current FY expenditures due to AP.
- June (three business days before end of month): June timecards due to Payroll, including scheduled work hours thru 6/30. Ensure all hours worked during current FY have been approved and submitted to Payroll for processing.
- June 30: All purchases must be received and services rendered for current FY budget.
- July 6: All approved current FY travel claims for reimbursement due to AP.
- July 15: All current FY expenditure transfer requests or allocation corrections due to Fiscal Services.
- July 15: All invoices due for final AP check run for current FY all invoices must be paid to be included in the current FY budget. If not paid, they will be charged to your next fiscal year's budget.
- July (three business days before end of month): July timecards due to Payroll. Include corrections for 6/27-6/30 hours scheduled but not worked.

New Procurement Card Reporting Requirement

Effective immediately, all District P-Card holders are required to submit additional supporting documentation aside from receipts for food purchases during staff meetings:

- For food purchases \$200 and below:
 - Names of participating employees
- For food purchases above \$200:
 - Names of participating employees
 - Purpose of meeting (a brief description is sufficient)
