1. Acknowledgment of Risks and Assumption of Liability

The undersigned acknowledges that participation in any school activities, including but not limited to instructional programs, pool use, field trips, excursions, and other school-sponsored events organized by Marin Community College District ("District"), involves inherent risks. These include, but are not limited to, risks of bodily injury, drowning, illness, accidents, property damage, and other unforeseen hazards. By signing this Agreement, the Participant (or their parent/legal guardian, if under 18) voluntarily assumes all risks associated with participation.

2. Transportation Agreement

Participant Information:

The District may or may not provide transportation for school activities. If the District does not provide transportation, the undersigned acknowledges that:

- The Participant is responsible for arranging transportation.
- The District is not liable for any accident, damages, injuries, or death resulting from private transportation arrangements.
- Any driver or vehicle used is not operating as an agent of the District.

3. Consent to Medical Treatment

In the event of an emergency, the undersigned consents to the provision of necessary medical care, including ambulance transportation, hospitalization, surgery, and treatment as determined by medical personnel. The undersigned acknowledges that the District is not responsible for medical expenses incurred.

4. Release of Liability

To the fullest extent permitted by law, the undersigned agrees to release, discharge, and hold harmless Marin Community College District, its trustees, officers, employees, agents, and volunteers ("Released Parties") from any claims, liabilities, damages, or expenses arising from participation in any school activities, including but not limited to academic programs, extracurricular activities, athletic events, pool use, field trips, excursions, and other school-sponsored events, except in cases of gross negligence or intentional misconduct.

5. Indemnification

The undersigned agrees to indemnify and defend the Released Parties from any claims arising from their participation in school activities.

6. Conduct and Compliance

The Participant agrees to abide by all rules and regulations set forth by the District. The District reserves the right to remove a Participant from an activity if their behavior poses a risk to themselves or others.

7. Photography, Video & Media Release

The undersigned authorizes the District to use photographs, videos, or audio recordings of the Participant for promotional and educational purposes without compensation. This includes but is not limited to, brochures, social media, websites, and other forms of media. The undersigned acknowledges that they have no expectation of privacy concerning such media use and waive any right to approve the final product.

8. Severability & Entire Agreement

If any provision of this Agreement is found to be unenforceable, the remaining provisions shall remain in effect. This Agreement constitutes the entire agreement between the undersigned and the District regarding participation in all school activities.
